- The portion of a record that identifies security systems or access codes. § 610.021(20), RSMo.
- Records that identify and would allow unauthorized access to or unlawful disruption of the configuration of components or the operation of a computer, computer system, computer network or telecommunications network. § 610.021(21), RSMo.
